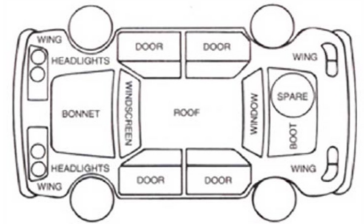

The full damage deposit will be charged for smoking in any Vehicle(s). This is a per vehicle charge. Other fees may be assessed depending on the damage caused by the smoke to the Vehicle(s). Vehicle may not be driven or moved out of the State of Florida.

SCRATCHED OR DAMAGED RIMS

A \$500 fee will be applied per rim that returns with scratches. This will be taken from the damage deposit upon return of the vehicle.

SPEEDING

If vehicle exceeds the posted speed limit, the vehicle will be repossessed and the security deposit becomes nonrefundable.

95 Auto Club will allow a one HOUR grace period from the return time specified in the contract. Thereafter, the agreed hourly rate will apply. After 6 hours, Renter/Member will be assessed the daily rate.

1. **DEFINITIONS OF TERMS** In this Agreement, unless the context indicates otherwise: "Additional Driver" means any person, in addition to the Driver, duly authorized by 95 Auto Club to drive the Vehicle. "Auto Dealers Guide" means the Kelley Blue Book publication containing recommended retail values of motor vehicles. "Claims Administration Fee" means the administrative fee charged whenever a claim is processed relating to damage, loss, or theft of the Vehicle. "Contract Fee" means a one-time charge per rental, including but not limited to storage of original documents. "Damages" means all actual costs incurred by 95 Auto Club, including but not limited to towing, transport, storage, repairs (including tires and rims), replacement of parts or accessories without depreciation, expert inspections and reports, and any related charges. An invoice, quotation, or job card produced by 95 Auto Club shall constitute prima face proof of such costs. "Repairer or Supplier of Our Choice" means 95 Auto Club reserves the exclusive right to designate repair facilities and replacement part suppliers. "Day" means a 24-hour period or any part thereof, calculated from the time of vehicle checkout. "Driver" means any person duly authorized by 95 Auto Club to operate the Vehicle as reflected in this Agreement. "Extend" means any authorized extension of the Rental Period approved by 95 Auto Club. "First Amount Payable / Excess" means the amount for which the Renter remains responsible in the event of damage, loss, or theft. "Official Rates Brochure" means 95 Auto Club's current published rate schedule and rental information. "Rental Period" means the duration from the date and time out to the agreed return date and time, including any approved extensions. "Renter" means all persons listed on this Agreement, jointly and severally, including the Driver and any Additional Driver. "Renting Location" means the 95 Auto Club location from which the Vehicle is rented or another agreed-upon location. "Vehicle" means the motor vehicle described in this Agreement, including all keys, tools, tires, accessories, equipment, documents, and any authorized replacement vehicle. "Traffic Fine Administration Fee" means the fee charged by 95 Auto Club to administer traffic violations incurred during the Rental Period. "Total Loss" means: (a) Damage where repair costs are deemed uneconomical at 95 Auto Club's sole discretion, or (b) Theft or permanent loss of the Vehicle. The value will be based on the Auto Dealers Guide retail value or manufacturer's list price, less salvage. "Waiver" means any reduction of liability elected by the Renter. Words importing the singular include the plural and vice versa. References to any gender include all genders. Natural persons include legal entities and vice versa.

2. **RENTAL OF THE VEHICLE** 95 Auto Club rents the Vehicle to the Renter subject to these Terms & Conditions. The Renter is bound by this Agreement whether or not they personally operate the Vehicle.

3. **DELIVERY OF THE VEHICLE** Risk and possession transfer upon delivery of the keys and/or Vehicle to the Renter, Driver, or Additional Driver at the Renting Location. The Vehicle is deemed delivered in good order and condition unless damage is documented in writing and signed by both parties. The Vehicle will be delivered fully fueled.

4. **USE OF THE VEHICLE** The Vehicle may only be used during the Rental Period and any authorized extension. The Vehicle may not be used: For hire or reward. To tow or propel another vehicle without written authorization. For illegal purposes or customs violations. In motorsport or high-risk activity. Outside the State of Florida without written authorization. In areas of civil unrest or similar risk. The Renter must secure the Vehicle at all times, activate alarms, and retain control of keys. Failure to remove removable radio faces (if applicable) resulting in loss is the Renter's responsibility. Smoking is strictly prohibited. A \$500 cleaning fee applies for violations. Ownership of the Vehicle remains with 95 Auto Club at all times.

5. **RETURN OF THE VEHICLE** The Vehicle must be returned on time, at the agreed location, fully refueled, and in the same condition. Failure to return constitutes unlawful possession and may result in repossession, reporting to authorities, forfeiture of waivers, and liability for all retrieval costs. Risk remains with the Renter until return is officially recorded by 95 Auto Club.

6. **TERMINATION / CANCELLATION / EXTENSION** 95 Auto Club may terminate this Agreement at any time upon notice. Extensions require 24 hours' prior notice and written acceptance by 95 Auto Club.

7. **RENTER / DRIVER WARRANTIES** Only authorized Drivers may operate the Vehicle. No Driver may operate the Vehicle while impaired or without a valid license. Physical impairments must be disclosed in advance. The Renter remains fully liable for all obligations regardless of who drives.

8. **RENTAL RATES & CHARGES** The Renter agrees to pay all rental charges, fees, waivers, insurance options, fuel, fines, penalties, administrative fees, and applicable taxes. Mileage is determined by odometer. Tampering results in a default charge of 500 miles per day. The Renter indemnifies 95 Auto Club for all fines and legal costs arising from vehicle use.

9. **PAYMENT TERMS** Payment is due on demand or at termination unless otherwise agreed. Credit card authorization permits 95 Auto Club to charge all amounts due, including damages. Damages exceeding \$10,000 will be supported by an independent assessor. Interest on overdue amounts may be charged at Prime + 3% or the legal maximum, whichever is higher.

10. **RENTER RISKS & LIABILITY** If personal insurance is not provided, the Renter is responsible for a \$10,000 deductible/security deposit. Waivers do not cover excess amounts or claims administration fees. Vehicles are registered and insured through MCO Network, Inc., 95 Auto Club, and affiliated entities.

11. **NO AGENCY** No Driver or Renter is an agent or employee of 95 Auto Club.

12. **ASSIGNMENT OF INSURANCE BENEFITS** The Renter assigns all insurance benefits, proceeds, and rights to 95 Auto Club, authorizes direct payment, grants power of attorney, and permits endorsement of insurance checks. Any uncovered losses remain the Renter's responsibility.

13. **PERSONAL ACCIDENT INSURANCE (PAI)** PAI is subject to the insurer's terms. 95 Auto Club bears no liability under such policies.

14. **ACCIDENT / LOSS PROCEDURE** Incidents must be reported to 95 Auto Club within 3 hours and to police within 24 hours. Failure to comply results in full liability. The Renter must cooperate fully with investigations and claims.

15. **INDEMNITY** The Renter indemnifies 95 Auto Club and its affiliates against all claims, losses, or damages arising from vehicle rental or use.

16. **LOSS OF USE & DIMINISHED VALUE** Renter is liable for lost rental revenue and diminished vehicle value. Insurance denial may result in liability of up to three times the vehicle's market value.

17. **GENERAL PROVISIONS** This Agreement is governed by the laws of the State of Florida and the United States. Legal costs incurred by 95 Auto Club are recoverable in full. Vehicles may be equipped with monitoring systems, and recorded data may be used in enforcement or legal proceedings. Drivers not listed as the Renter bind themselves as surety and co-principal debtor.

18. **ENTIRE AGREEMENT** This document constitutes the entire agreement between the parties. No verbal representations are binding unless confirmed in writing by 95 Auto Club.

The Renter acknowledges that certain vehicles may be fitted with a vehicle management system, which is used to inter alia, record speed and other information relating to the vehicle rented. 95 Auto Club shall be entitled to use such information (including in court proceedings) as it deems fit. If the Driver and/or Additional Driver (if applicable) is not the same as the Renter/Member, then the Driver and/or Additional Driver shall bind himself/herselves as surety and co-principal debtor in solidum with the Renter/Member in favor of 95 Auto Club for the due fulfillment of all of the obligations of the Renter to 95 Auto Club in terms of this agreement.

18. **ENTIRE AGREEMENT:** This document contains the entire agreement between the parties regarding the matters contained herein and no party shall be bound by any undertakings, representations, warranties, promises or the like not recorded in writing by 95 Auto Club, other than 95 Auto Club agreeing to extend the agreed return date for the vehicle.
